ABOUT BJUT

Beijing University of Technology (BJUT) was established in 1960, in the southeast area of Beijing. It is a high-level multi-disciplinary research university providing programs in science, engineering, economics, management, literature, law, art and education, with engineering as a core focus. In 1981, BJUT was approved as one of the first universities in China to confer Master's Degrees. In 1985, BJUT was approved to confer Doctoral Degrees. In 1996, BJUT entered the list of key universities in the national "211 Project". In 2017, BJUT officially entered the list of universities in the national "Double First-Class" Initiative.
